

# FAREWELL TO NUCLEAR ARMS CONTROL? How to Handel Atomic Threats in Europe

MONDAY 3 - WEDNESDAY 5 JULY 2023 Protestant Academy Loccum

The nuclear (dis)order is shifting. Russia's full-scale invasion of Ukraine has further accelerated the erosion of the arms control architecture which started to become brittle some time ago. With Vladimir Putin's announcement to suspend Russia's participation in the New START treaty, many ask if we have to say farewell to nuclear arms control. In parallel, new and old nuclear powers around the world have taken efforts to modernize or even increase their atomic arsenals. Technological trends are posing challenges to strategic stability. On the multilateral dimension opposing views on nuclear weapons and fragmentation upon different approaches of disarmament continues to linger and further nourish the frustration with the implementation of the Non-Proliferation Treaty (NPT) and the inequality of the nuclear (dis)order.

How will Europe handle this situation? This event will bring together arms control experts, practitioners, and activists from across Europe to assess and evaluate the current situation. The conference aims to provide a forum that fosters innovative policy ideas to reduce threats and risks. Thereby, we focus particularly on the European "nuclear non-haves" and ask what role they could play in the future.

The conference is **bilingual** meaning that we provide throughout the sessions **simultaneous German-English interpretation**. The **public event** brings together actors from **different walks of life** who are all united by the fact that they are interested in the subject of the conference. However, this setting requires that we **strictly follow the Chatham House rules**. This is a draft program and may be subjected to change.

As nuclear arms control was eroding in recent years, the demands for its revitalization became more and more urgent and pronounced. With the war in Ukraine, the outlook has become even bleaker. Vladimir Putin's announcement in late February to suspend Russia's participation in the New START treaty has put a big questions mark at the fate of future bilateral arms control initiatives. This "policy perspective panel" and the following "analysts session" (next morning) will address among others the following questions: What structural challenges is arms control facing today in the era of geopolitical rivalry? Is there at all a future for bilateral arms control between the United States and Russia? Would it be possible to engage China in arms control? Will non-traditional/non-treaty-based approaches to arms control have a chance? Etc.
